REPORT OF THE DEPUTY CHIEF

FORMER BLAINA FIRE & RESCUE STATION PROPOSED DISPOSAL STRATEGY**SUMMARY**

This report seeks approval to declare the former Blaina Fire & Rescue Station a surplus asset and proceed with its disposal.

RECOMMENDATION

That Members declare the former Blaina Fire & Rescue Station surplus to requirements.

That Members approve the disposal strategy outlined in the report.

1. BACKGROUND

- 1.1 The Fire Cover Review for Blaenau Gwent (2013) recommended the closure of the subject Station. Subsequently Blaina Fire & Rescue Station closed on the 31 March 2015. The Service has reviewed its operational requirements and confirm that it has no further operational use for the asset. On that basis approval is sought to declare the former Blaina Fire & Rescue Station surplus to requirements.
- 1.2 In order to remove the holding costs associated with the vacant building, and to generate a capital receipt, it is recommended that the Authority agree to proceed with a disposal of the site.

2. ISSUE

- 2.1 The asset has the potential for an ongoing use of the existing building or for redevelopment subject to the necessary planning permissions being granted. However, as Members will recall, the building contains high levels of asbestos that will need to be considered by potential purchasers. This could limit the capital receipt we receive.
- 2.2 The site is now vacant and all operational equipment has been removed from the building. Costs for the removal of the asbestos have been sought and consent to demolish the building has been approved by the local planning authority. However, there has been an expression of interest in the site locally, which it is important for Members to consider.

- 2.3 In order to test the open market and realise a sale within the shortest timescale possible whilst at the same time limiting the Service's holding costs it is recommended that we proceed by way of auction with a reserve set at a level that will improve the likelihood of a disposal.
- 2.4 Proceeding by way of auction allows us to make the property available to the wider market to ensure we achieve best value. It also reduces the timescales involved in a sale by ensuring the successful bidder exchanges on the date of auction with completion following within a reasonable period thereafter. The Authority is then protected from the uncertainty of timelines which arise in a private deal.
- 2.5 The next local auction the Authority could meet would be July and the closing date for submissions for that auction is the date of this meeting. If the Authority is unable to reach a decision on this issue today, the Service has been advised that it would be better to wait until the September auction rather than one in August.
- 2.6 An element of flexibility is sought within the disposal strategy outlined to ensure that if the asset fails to sell at auction officers have the ability to secure a sale via private treaty on the most economically advantageous terms available, which may involve the Service securing demolition of the building on site.

3. FINANCIAL IMPLICATIONS

- 3.1 The asset is incurring holding costs associated with a vacant building. The anticipated capital receipt at auction is unknown, although is unlikely to be substantial given the level of asbestos within the building. Officers will liaise with the auctioneers in relation to the reserve to be placed on the site once marketing has commenced and public interest is gauged. Costs for demolition of the building and controlled removal and disposal of the asbestos are in the region of £75,000.

4. RECOMMENDATION

It is recommended that Members:

- 4.1 Declare the former Blaina Fire & Rescue Station surplus to requirements.
- 4.2 Approve the disposal strategy outlined in the report.
