1. EMPLOYMENT, BUSINESS, TRADE, PROFESSION, OFFICE OR VOCATION

(Para 10 (2) (a) (i & ii) of the Code of Conduct:

You must regard yourself as having a personal interest in any business of your authority if it relates to, or is likely to affect -

- any employment or business carried on by you;*
- any person who employs or has appointed you, any firm in which you are a partner or any company for which you are a remunerated director)*

³ You do not need to show the extent of your interest. A company or body corporate is active in the Fire & Rescue Authority's area if it has land or a place of business in that area. The requirement also covers shares and securities held in the name of other people in which you have a beneficial interest.

(Para 10 (2) (v) of the Code of Conduct:

You must regard yourself as having a personal interest in any business of your authority if it relates to, or is likely to affect -

- *any contract for goods, services or works made between your authority and you or a firm in which you are a partner, a company of which you are a remunerated director, or a body of the description specified in sub-paragraph (iv) above)*

6. PUBLIC AND OTHER BODIES

(Para 10 (2) (viii & ix) of the Code of Conduct:

- *any body to which you have been elected, appointed or nominated by your authority;*
- *any -*
 - *public authority or body exercising functions of a public nature;*
 - *company, industrial and provident society, charity, or body directed to charitable purposes;*
 - *body whose principal purposes include the influence of public opinion or policy;*
 - *trade union or professional association; or*
 - *private club, society or association operating within your authority's area, in which you have membership or hold a position of general control or management)*

⁵ Land includes buildings or parts of buildings. You should also include any property:

- (i) from which you receive rent;
- (ii) of which you are the mortgagee;
- (iii) any land over which you have a licence;
- (iv) any land which you have the right to occupy, but neither own nor have a tenancy of (this would include for example informal allotments, use of a field etc).

⁶ That is, in which you have some proprietary interest for your own benefit.

(f) **Private club, society or association operating within the Fire & Rescue Authority's area.**

7. OTHER INTERESTS DISCLOSABLE UNDER THE CODE OF CONDUCT

To declare other interests that the Member is aware of now or becomes aware of during the term of office that require to be disclosed under the Members' Code of Conduct and includes interests under paragraphs 10 (2) (b).

- (b) *a decision upon it might reasonably be regarded as affecting—*
- (i) *your well-being or financial position, or that of a person with whom you live, or any person with whom you have a close personal association;*
 - (ii) *any employment or business carried on by persons as described in 10(2)(c)(i);*
 - (iii) *any person who employs or has appointed such persons described in 10(2)(c)(i), any firm in which they are a partner, or any company of which they are directors;*
 - (iv) *any corporate body in which persons as described in 10(2)(c)(i) have a beneficial interest in a class of securities exceeding the nominal value of £5,000; or*
 - (v) *any body listed in paragraphs 10(2)(a)(ix)(aa) to (ee) in which persons described in 10(2)(c)(i) hold a position of general control or management,*
- to a greater extent than the majority of—*
- (aa) *in the case of an authority with electoral divisions or wards, other council tax payers, rate payers or inhabitants of the electoral division or ward, as the case may be, affected by the decision; or*
 - (bb) *in all other cases, other council tax payers, ratepayers or inhabitants of the authority's area.*
