- (i) from which you receive rent;
- (ii) of which you are the mortgagee;
- (iii) any land over which you have a licence;
- (iv) any land which you have the right to occupy, but neither own nor have a tenancy of (this would include for example informal allotments, use of a field etc).

<sup>6</sup> That is, in which you have some proprietary interest for your own benefit.
