**SOUTH WALES FIRE & RESCUE AUTHORITY
AUDIT OF ACCOUNTS 2024/25**

Audit notice where Responsible Financial Officer has certified the accounts, but audit has not been completed so the audited body is not able to publish audited accounts.

Regulation 10(1) of the Accounts and Audit (Wales) Regulations 2014 (as amended) requires that Responsible Financial Officer of South Wales Fire and Rescue Authority to sign and date the statement of accounts, and certify that it presents a true and fair view of the financial position of the body at the end of the year to which it relates and of that body's income and expenditure for that year. The Regulations require that this be completed by 31 May 2025, and the unaudited Statement of Accounts were signed and certified by the Responsible Financial Officer on 30 May 2025.

The audit of the statement accounts for South Wales Fire & Rescue Authority for the year ended 31 March 2025 has not been concluded. As required by regulation 10(2) of the Accounts and Audit (Wales) Regulations 2014 (as amended), the audited accounts are not available for publication by the 31 July 2025 deadline.

The delay is due to the ongoing audit by the Auditor General for Wales, which has not yet completed. The statement of accounts will be published as soon as reasonably practicable after the conclusion of the audit and the issue of the audit certificate and opinion.

This notice is published in accordance with Regulation 10(2)(b) of the 2014 Regulations.
