O Ddydd Llun 10 Fehefin i Ddydd Gwener 5 Gorffennaf 2019, rhwng 9:00am a 5:00pm ar Ddydd Llun i Ddydd Iau a 9:00am a 3:00pm ar Ddydd Gwener, gall unrhyw berson sydd â diddordeb wneud cais i'r Adran Gyllid, Gwasanaeth Tân ac Achub De Cymru, Pencadlys, Parc Busnes Forest View, Pont-y-clun, er mwyn cael archwilio a gwneud copïau o'r cyfrifon ar gyfer y flwyddyn a orffennodd ar 31ain Mawrth 2019.
2. Ar, neu ar ôl 10.00am ar 8 Gorffennaf 2019 hyd nes y cwblheir yr archwiliad, bydd yr Archwilydd, drwy ddymuniad etholwr llywodraeth leol ar gyfer yr ardal lle mae'r cyfrifon yn perthyn, yn rhoi i'r etholwr neu'i gynrychiolydd gyfle i'w holi ynglŷn â'r cyfrifon a gall unrhyw etholwr neu'i gynrychiolydd gwrdd â'r Archwilydd i fynegi gwrthwynebiadau ar unrhyw fater y gallai'r Archwilydd weithredu yn ei erbyn o dan adrannau 32 Gorchymyn Deddf Archwilio Cyhoeddus (Cymru), (sef, agwedd anghyfreithlon ar y cyfrif, methiant dod â swm i gyfrif neu golled neu ddiffygiad a achoswyd gan gamymddygiad bwriadol), neu wneud adroddiad er lles y cyhoedd o dan adran 22 o'r Ddeddf.

From Monday 10 June to Friday 5 July 2019 inclusive between the hours of 9:00am and 5:00pm on Monday to Thursday and 9:00am and 3:00pm Friday, any person interested on application to the Finance & Procurement Department, South Wales Fire & Rescue Service, Headquarters, Forest View Business Park, Pontyclun may inspect and make copies of the accounts for the year ended 31 March 2019.

On or after 8 July 2019 at 10.00am until the completion of the audit, the Auditor, at the request of a local government elector for the area to which the accounts relate, will give the elector or his representative an opportunity to question him about the accounts and any such elector or his representative may attend before the Auditor and make objections as to any matter in respect of which the Auditor could take action under section 32 of the Public Audit (Wales) Act (namely, an unlawful item of account, failure to bring a sum to account, or a loss or deficiency caused by wilful misconduct), or could make a report in the public interest under section 22 of the Act.
