**Whilst we have provided you with most of our fleet information, some specialist details of our vehicle equipment may have been omitted under section 24 (1) of the FOIA 2000 relating to national security. In providing the full information of our specialist equipment vehicles we may be putting our services and duties of protecting the public at potential risk –highlighting our capability and resources to respond to incidents. It is therefore concluded that the release of this particular information may prejudice national security which is exempt under 24 (1) FOIA**

In relation to your request for number plates and station locations, this information is considered to be exempt from disclosure under Section 31(2i) of the Freedom of Information Act to the release of vehicle registration numbers/station locations, as the Service believes that the release of this particular information into the public domain would create a vulnerability in our aim to protect our valuable assets and maintain the effective operation of our emergency provision.

We believe that a full list of vehicle registration numbers and locations would present a threat to our services and to securing the health, safety and welfare of SWF&RS staff, visitors and members of the community that we serve (s.31(2i)).
