We are unable to specify if cladding played a contributory role in the fire, but a search of our incident logs have identified 29 fires where cladding was involved

Incident reports do not specifically ask for materials contributing to fire but a search of incident logs uncovered one instance of plastic cladding involved and five instances of wooded cladding involved in a fire.
