You asked us:

I am trying to locate information pertinent to the changes of the 1992 pension scheme to the 2015 firefighters pension scheme. The information I am specifically requesting is any email which has the text "claimants" "1992 pension" "transitional protection" listed in it

Our response:

We only hold/store email information for disaster recovery purposes, it is therefore not possible to search through all messages and all users without carrying out a manual process. To implement a manual check could take months and would tie up numerous SWFRS staff resources. We are therefore unfortunately declining your request on the basis of section 12 (cost/ time limit). This acts as a refusal notice, if you wish to make another request or to narrow your request to specific documents that we may be better placed to locate please let us know and we will be happy to assist where possible.
