## **RE: Request for Information held by SWFRS**

Your request ref: IG000104 has been dealt with under the Freedom of Information Act 2000.

## You asked us:

- 1. The number of fires in your authority which have been reported on refurbishment works, in the last three years leading up to the date of your reply.
- 2. The amount of money your fire authority spent dealing with these fires.

## Our response:

- 1. We do not record general refurbishment work at the scene of incidents. We do collect if a property (residential, non-residential or outdoor building) is under construction at the time of a fire:
  - There have been 64 fires attended by South Wales Fire & Rescue between 1<sup>st</sup> April 2016 and 15<sup>th</sup> January 2020 (53 in the 3 years between 15<sup>th</sup> January 2017 and 15<sup>th</sup> January 2020), where the property has been classified as being under construction.
- 2. We are unable to quantify money expended on attending these incidents because of the complexities of the variables involved.
