Your request ref: IG000125 has been dealt with under the Freedom of Information Act 2000.

You asked us:

- 1. Your Brigade policy with regard to Houses in Multiple Occupation
 We have no specific policy regarding HMO. Our inspection programme is risk based and where audits are needed in HMO premises we work in collaboration with LA Housing Officers.
- 2. The number of properties registered as HMO in your brigade area 258 these are premises we have been made aware of over time. Local Authorities register properties therefore we may not be aware of all HMOs at present.
- 3. The addresses in a MS excel list of the HMO in the Brigade area See attached
- 4. The sources you use to become aware of HMO Consultation with Local Authorities/ incidents/information sharing with other organisations.
- 5. A list addresses of 4 storey buildings in MS excel format that have been individually inspected See attached
- 6. The date of inspection of the 4 storey buildings that have been individually in MS excel See attached
- 7. A list of addresses of 4 storey buildings that have been individually inspected but considered as not HMO
