You asked us:

I'd like to make a FOI request for any information the service holds on Aquila house

Our Response:

South Wales Fire and Rescue Service (SWFRS) can confirm that an appropriate inspection was carried out at Aquila House, Falcon Drive, Cardiff on 18th November 2019 and that a resultant action plan was served accordingly by SWFRS on 16th December 2021.

South Wales Fire and Rescue Service are currently dealing with the responsible persons and can confirm that they are engaging with us at this time.

Certain information about the property may be reasonably accessible to you by other means, such as requesting via CCHA directly.

However, SWFRS are not obliged to share information with you at this stage as it could be likely to prejudice the effective conduct of our public affairs, under Section 36 of the FOIA 2000. This letter therefore acts as a refusal notice. We are unable to release information to you as this could negatively impact on our public task duties undertaken by Business Fire Safety.
