Please could you include:

- -Vehicle make/model
- -Full registration
- -Full rear roof code
- -Vehicle role
- -vehicle base

Our Response:

The make/model of the operational vehicles owned by SWFRS is attached with this document

You will notice that within the fleet vehicle list, the vehicle registration number and vehicle base has not been provided.

In relation to cars listed as "Operational" these are made available through the Emergency Response Vehicle Lease Scheme

With the cars listed as "Non-Operational", these again are made available through a lease scheme.

As those vehicles are available for private use, the provision of the registration details could allow that individual (and/or their families) to be identified outside of their role with SWFRS. This would result in a breach of data protection legislation. Exemptions under S40 have been applied.


