You asked us:

Please supply me with data relating to fires on balconies on residential buildings in your area, as follows:

1. How many balcony fires occurred in the prior three years (2017 to 2020)? Please provide gross total and also breakdown by year.

Please note:

We do not specifically list balconies on our list of locations where a fire starts. The attached table includes all fires where balcony has been identified in the other location field on our Incident Recording System and any fires where the incident log reports a confirmed balcony fire.

2. How many building fires occurred where balconies contributed to the external spread of the fire?
We are unable to identify if balconies contributed to the external spread of the fire from the data held in our Incident Recording System.

3. The ratio breakdown of identified/suspected causes of these balcony fires (i.e.; barbecue, discarded cigarette, etc.).
