Your request ref: IG000610 has been dealt with under the Freedom of Information Act 2000.

You asked us:

In 2017, the employment courts decided – in the case of *Bear (Scotland) v Fulton* – that employers were required to take into account all remuneration earned (including non-guaranteed overtime) when calculating holiday pay. I wish to know the following:

- (1) Has your fire authority implemented this ruling? South Wales Fire and Rescue Service have implemented this ruling.
- (2) If the answer to (1) is yes, what date was the ruling implemented? The ruling was implemented in 2019, with 2 years back pay.

(3) If the answer to (1) is yes, was a collective agreement signed with the Fire Brigades Union or any other representative body prior to implementation? There was consultation with Trade Unions throughout the negotiation. A collective agreement was not signed.
