Your request ref: IG000879 has been dealt with under the Freedom of Information Act 2000.

You asked us:

My open questions with respect to firefighting mainly concern the following aspects:

1. Where does the South Wales Fire Authority get its water when extinguishing a fire? What are the regulations in terms of what needs to be available to you at the location?

We have various sources of water, i.e. Emergency Water from bulk water – open water, swimming pools, bowser provisions etc and the majority of it done via hydrants. Hydrant are owned by the water authority of which we adopt those required following guidance depending on what it is serving. Firefighter are allowed to use any hydrant insitu for firefighting purposes whether we have adopted it or not.

In relation as to what is needed at the location, this is dependent on what it is protecting. This information can be found within guidance such as National Guidance Document on the Provision of Water for Fire Fighting and the Guidelines for the Provision of Fire Hydrants on New Housing Developments etc.

The provisions our department covers is those on towns mains and of residential etc

- 2. Are there any differences in how this water is made available depending on the site (e.g. industrial vs. housing area)? What does it depend on?
- 3. How big is the share of instances in which you would use the water from on-site water tanks?

Water supplies to 'new' buildings should be in accordance with paragraph 16.8 of Approved Document B 2006 edition incorporating 2010 and 2013 amendments (for use in Wales) which states;

16.8 Where no piped water supply is available, or there is insufficient pressure and flow in the water main, or an alternative arrangement is proposed, the alternative source of supply should be provided in accordance with the following recommendations:

A. a charged static water tank of at least 45,000 litre capacity; or

B. a spring, river, canal or pond capable of providing or storing at least 45,000 litres of water at all times of the year, to which access, space and a hard standing are available for a pumping appliance; or

C. any other means of providing a water supply for firefighting operations considered appropriate by the fire and rescue authority
