- 6. **Property category and/or type** Dwelling/Other Residential/Non-Residential /Outdoor/Outdoor Structure/Road Vehicle/Rail Vehicle/Aircraft/Boat.
- 7. **Property Type** All four IRS levels of classification, ideally.
