You asked us:

I would like to request a full list of the PDA's used by SWFRS

Our response:

Please accept on behalf of South Wales Fire and Rescue Service our apologies for the delay in getting a response back to you, apologies for any inconvenience caused.

Your request above has been carefully considered. This acts as an official refusal notice- Section 24 exemption applies under the Freedom of Information Act 2000, in that disclosure of such required information would impact on National Security.

The detail of sensitive information you require would make our mobilising document list vulnerable and expose our responses to multiple National incident types, including but not limited to terrorist related incident response planning. As a result this could also likely impact and prejudice the effective conduct of public affairs, in us effectively undertaking our public task duties as a Category 1 Emergency Responder.

Due also to the size of the information held in regards to specific PDAs, not only this but the request would take us above the time and cost limit under FOIA 2000 to locate and work through. This would include the time to identity, retrieve and search for information potentially covering thousands of specific PDAs.
