**SWFRS currently have 47 Operational Fire Stations and 3 Corporate buildings. All facilities are operated or managed in house by our Operations and Property Departments.**

**We have 74 front line appliances, this includes 10 spare appliances.**

**As of the 1<sup>st</sup> December 2021 the Service employed 1634 personnel**
