South Wales Fire and Rescue Service are working towards the requirements of the Competency Framework for Fire Safety Regulators.

RAISING AWARENESS - REDUCING RISK



The roles of a Fire Safety Auditor, Inspector and Manager are performed by personnel employed under Grey book conditions of service.

Crew Managers (CM) and Watch Managers (WM) perform the role of a Fire Safety Advisor and a Fire Safety Inspector. These roles are performed during the core hours of 07:00 – 21:00. The salary for a CM and WM is between £34,269 and £37,535.

Station Managers (SM) and Group Managers (GM) perform the role of a Fire Safety Manager. The salary for a SM is between £41,578 and £42,827 and the salary for a GM is between £47,887 and £53,086. Both roles receive an enhancement of 20% if they work within the flexi-duty system. SM's working on a flexi-duty system provide a fire safety role outside core hours when required.

4 How many staff of each role do you employ

To fulfil the roles as detailed within the framework, South Wales Fire and Rescue Service employ five Group Managers, 14 Station Managers, 21 Watch Managers, four Crew Managers.
